

OUR PRIVACY POLICY

We respect your privacy. We do **not** sell, rent, trade or give private information like email addresses, home addresses, telephone numbers or names about our members or guests to any other parties. **Your private information stays private.**

We have created this Privacy Policy in order to demonstrate our firm commitment to helping our users better understand what information we collect about them and what may happen to that information.

OVERVIEW

As part of the normal operation of our services we collect and, in some cases, may disclose information about you. This Privacy Policy describes the information we collect about you and what may happen to that information. By accepting this Privacy Policy and our Terms and Conditions, you expressly consent to our use and disclosure of your personal information in the manner prescribed in this Privacy Policy. This Privacy Policy is incorporated into and subject to the terms of the Terms and Conditions.

This Privacy Statement applies to all related sites. All other worldwide sites operate under similar privacy practices as described in this Privacy Policy, and subject to the requirements of applicable local law, we strive to provide a consistent set of privacy practices throughout the online personals sites.

§ 1 A SPECIAL NOTE ABOUT CHILDREN

Children are not eligible to use our services, and we ask that minors under the age of 18 do not submit any personal information to us.

§ 2 INFORMATION WE COLLECT

Information we may collect from you:

- contact information
- general information
- personal information
- profile information
- financial information
- photos of you

This includes your full name, your residential address, your email address, your phone number, your age, your occupation, description of your appearance

Our primary goal in collecting personal information is to provide you with a smooth, efficient, and customized experience. This allows us to provide services and features that most likely meet your needs and to customize our service to make your experience easier. You agree that in order to assist our members to meet each other we may feature members' profiles in our editorials and newsletters that we send out from time to time to our members. Your name, address and telephone number are confidential and will not be posted in your profile. Your profile is available for other members to view. Members' profiles include a description and photos, likes and dislikes, individual essays and other information helpful in determining matches. Your viewable profile does not include any identifying information about you, except your first name or your username you chose upon registering, your photo or any other information you choose to publish.

Data Storage

Please note that your personally identifiable information will be stored and processed on our computers. The laws on holding personal data may differ from country to country. We will hold and transmit your information in a safe, confidential and secure environment. We automatically track certain information to improve our Service and our Website for statistical purposes. This information may include:

- the type of browser used
- the number and type of pages viewed
- the referring URL
- the exit URL
- the time and date of visits
- the IP address

We are using cookies and other devices. We use this information for internal research on our members' demographics, interests, and behavior to better understand and serve you and our community. We use data collection devices such as "cookies" on certain pages of our Websites. "Cookies" are small files placed on your hard drive that assist us in providing customized services. We also offer certain features that are only available through the use of a "cookie". Cookies can also help us provide information which is targeted to your interests. Most cookies are "session cookies", meaning that they are automatically deleted from your hard drive at the end of a session. You are always free to decline our cookies if your browser permits. It might occur that this will limit your access to features on or site.

We use a third party advertising company, to serve ads on our behalf across the Internet. The third party may also collect anonymous information about your visits to our Web site. This is primarily accomplished through the use of a technology device, commonly referred to as a Web beacon or an action tag, which we place on various Web pages within our Web site or in an html e-mail that allows Atlas DMT to collect anonymous information. Atlas DMT may use information about your visits to this and other Web sites in order to provide ads about goods and services of interest to you.

§ 3 OUR USE OF YOUR INFORMATION

We use information in the files we maintain about you, and the other information we obtain from your current and past activities on the Websites to resolve disputes, troubleshoot problems and enforce our Terms and Conditions. At times, we may look across multiple members to identify problems or resolve disputes, and in particular we may examine your information to identify members multiple Member ID No. or aliases. You agree that we may use personally identifiable information about you to improve our marketing and promotional efforts, to analyze site usage, improve our content and product offerings, and customize our Site's content, layout, and services. These uses improve our site and better tailor it to meet your needs. You agree that we may use your information to contact you and deliver information to you that, in some cases, are targeted to your interests, such as targeted banner advertisements, administrative notices, product offerings, and communications relevant to your use on the Websites. By accepting this Privacy Policy, you expressly agree to receive this information.

§ 4 OUR DISCLOSURE OF YOUR INFORMATION

Due to the existing regulatory environment, we cannot ensure that all of your private communications and other personally identifiable information will never be disclosed in ways not otherwise described in this Privacy Policy. By way of example (without limiting and foregoing), we may be forced to disclose information to the government, law enforcement agencies or third parties. Under certain circumstances, third parties may unlawfully intercept or access transmissions or private communications, or members may abuse or misuse your information that they collect from our Websites. Therefore, although we use industry standard practices to protect your privacy, we do not promise, and you should not expect, that your personally identifiable information or private communications will always remain private.

As a matter of policy, we **do not** sell or rent any personally identifiable information about you to any third party. However, the following describes some of the ways that your personally identifiable information may be disclosed.

4.1. Financial Information

Under some circumstances we may require some additional information, such as, but not limited to credit card details. We use this financial information, including your name, address, and other information, as well as to bill you for use of our services. We use your financial information to check your qualifications, to bill you for services and/or products, to enable you to participate in discount, rebate and similar programs in which you may elect to participate. By making a purchase, or engaging in any other kind of activity or transaction that uses financial information on the Websites, you consent to our providing of your financial information to our service providers and to such third parties as we determine are necessary to support and process your activities and transactions, as well as to your credit card issuer for their purposes. These third parties may include the credit card companies and banking institutions used to process and support the transaction or activity. By purchasing, or registering or making reservations for products or services of third parties offered on the Websites, or by participating in programs offered on the Websites that are administered by third parties and that require you to submit financial information in order to use them, you also consent to our providing your financial information to those third parties. Any of these various third parties may be authorized to use your financial information in accordance with our contractual arrangements with such third parties and in accordance with their own privacy policies, over which we have no control, and you agree that we are not responsible or liable for any of their actions or omissions. Additionally, you agree that we may use and disclose all such information so submitted to such third parties in the same manner in which we are entitled to use and disclose any other information that you submit to us.

4.2. Advertisers

We aggregate (gather up data across all our members' accounts) personally identifiable information and disclose such information in a non-personally identifiable manner to advertisers and other third parties for other marketing and promotional purposes. However, in these situations, we do not disclose to these entities any information that could be used to identify you personally. Certain information, such as your name, email address, password, credit card number and bank account number, are never disclosed to marketing advertisers. We may use third-party advertising companies to serve ads on our behalf. These companies may employ cookies and action tags (also known as single pixel gifs or web beacons) to measure advertising effectiveness. Any information that these third parties collect via cookies and action tags is completely anonymous.

4.3. External Service Providers

There may be a number of services offered by external service providers that help you use our Websites. If you choose to use these optional services, and in the course of doing so, disclose information to the external service providers, and/or grant them permission to collect information about you, then their use of your information is governed by their private policy.

4.4. Other Corporate Entities

We share much of our data, including personally identifiable information about you, with our parent and/or subsidiaries that are committed to serving your online needs and related services, throughout the world. To the extent that these entities have access to your information, they will treat it at least as protectively as they treat information they obtain from their other members. Our parent and/or subsidiaries will follow privacy practices no less protective of all members than our practices described in this document, to the extent allowed by applicable law. It is possible that We and/or its subsidiaries, or any combination of such, could merge with or be acquired by another business entity. Should such a combination occur, you should expect that we would share some or all of your information in order to continue to provide the service. You will receive notice of such event (to the extent it occurs) and we will require that the new combined entity follow the practices disclosed in this Privacy Policy.

4.5. Legal Requests

we cooperates with law enforcement inquiries, as well as other third parties to enforce laws, such as: intellectual property rights, fraud and other rights. We can (and you authorize us to) disclose any information about you to law enforcement and other government officials as we, in our sole discretion, believe necessary or appropriate, in connection with an investigation of fraud, intellectual property infringements, or other activity that is illegal or may expose us or you to legal liability.

§ 5 YOUR USE OF OTHER MEMBERS INFORMATION

As a member you have access to the Member's ID No., and you might obtain other information of member(s) through the regular use of the instant messaging and chat rooms and email communications. By accepting this Privacy Policy, you agree to use information about other members only for communications related to this Website and that are not commercial messages and that are in agreement with our [Terms and Conditions](#). Under no circumstances, except as defined in this Section, can you disclose personally identifiable information about another member to any third party without our consent and the consent of such other member after adequate disclosure. We and our members do not tolerate spam. Therefore, without limiting the foregoing, you are not licensed to add a DatingWalk.com member to your mail list (email or physical mail) without their express written consent after adequate disclosure. § 6 ACCESSING, REVIEWING AND CHANGING YOUR PROFILE

Following registration, you can review and change the information you submitted during registration through the Member Service Menu including: Your password and e-mail address. To the extent that we use third party advertisers, they adhere to their own privacy policies. Since we do not control the privacy policies of the third parties, you are subject to ask questions before you disclose your personal information to others.

§ 9 SECURITY

We use industry standard practices to safeguard the confidentiality of your personal identifiable information. We treat data as an asset that must be protected against loss and unauthorized access. However, "perfect security" does not exist on the Internet.

§10 NOTICE

We may change this Privacy Policy from time to time based on your comments and our need to accurately reflect our data collection and disclosure practices.
